



## ST DAMIEN'S CATHOLIC PRIMARY SCHOOL

*The following fees and charges are applicable  
for the 2021 school year*

### APPLICATION FEE

Non-refundable payment of \$50.00 per family (inc. GST) intended to offset the cost of processing applications.

### TUITION FEE

#### 3 Yr Old Kindergarten

\$67 per session (no sibling discount)

#### 4 Year Old Kindergarten

\$615 per annum (3 days per week)

2nd child Kindy - 20%

\$492 per annum

3rd child Kindy - 40%

\$369 per annum

4th child Kindy or more - 100%

***NEW - Sibling discounts may apply to students with older siblings at Mandurah Catholic College. An application for this fee reduction is available from the school office.***

**INSTRUMENTAL TUITION FEE** – approx \$1010.00 per Music Student

Invoices and payment will be made directly to MCC.

### PARENTS & FRIENDS' LEVY

The levy is \$90.00 per annum per family and contributions go towards purchasing various resources and equipment considered necessary to provide quality education to all students of the School.

### BUILDING LEVY

This is a fee of \$205 per annum, per family. (For families with a child only attending Kindergarten, the annual contribution will be \$160)

### AMENITIES FEE

This fee will be \$435 per annum per primary student and \$325 per Kindergarten child.

### CAMPS

The cost of the compulsory Year 6 Camp for 2021 will be: \$555

The cost of the compulsory Year 5 Camp 2021 will be : \$115

### EDUCATION PACKS – 2021

A component of your Annual School Fee Invoice is your child's Education Pack. This pack includes many necessary aspects that will enable your child's teacher to deliver a full and comprehensive curriculum. Stationary items will be made into Book Packs and will be distributed by the classroom teacher. (*Book packs may be tax deductible – refer to your tax accountant*)

**Kindergarten:** \$130

**Pre-primary:** \$195

**Years 1 to 6:** \$255

## **IT LEVY**

This levy is to provide appropriate high standards of technology, which is a dynamic and ever changing entity and, as such, this levy system will allow StDCPS the flexibility to continue to offer an outstanding technology program.

Students in Years 3/4/5 in 2021 will pay an annual levy. The levy includes the iPad, Griffin survivor case, keyboard, insurance and maintenance. Parents will then have the option to purchase the device when their child leaves at the end of Year 6 for a gold coin donation.

## **PAYMENT OPTIONS FOR FEES**

A fee commitment form is required to be signed with your preferred method of payment. Any variance must be discussed with the Bursar.

The total fee is payable by:

- a) One annual payment by the first instalment due date, or
- b) Three instalments, or
- c) By special arrangement negotiated with the Principal /Bursar (Phone 9583 2500).
- d) Direct Debit is also available. Forms may be obtained from the School Office.

Fees paid by three instalments are payable by the following dates:

1st instalment	31 March, 2021
2nd instalment	31 May, 2021
3rd instalment	31 July, 2021

## **CONCESSIONS**

The School Board will be sympathetic towards parents with genuine needs who require financial assistance.

Parents seeking assistance should submit an application with supporting evidence to the Principal. These applications should be made as close to the start of the school year as possible.

All concessions relate only to the year in which the application is made and should there be a need to continue, the arrangement must be re-negotiated on an annual basis.

## **HEALTH CARE CARD / PPS CONCESSION CARD**

The scheme operating in 2021 within the Catholic Education system will continue. Parents should approach the school office with regard to any eligible discount on fees as holders of Health Care Cards or PPS Concession Cards. Current cards must be submitted to office before 28<sup>th</sup> February 2020.

## **NOTICE OF WITHDRAWAL**

Parents are required to give one term's notice in writing if they intend to withdraw their child from the school during the course of the school year.

If a student is withdrawn without notice at the end of a term, the following term's fee and levy are payable in full. If a student is withdrawn without notice during a term, that term's fee and levy, and a proportion of the following term's fee and levy will be payable.
